TI updates first-quarter 2008 business outlook

- · Revenue expected between \$3.21 billion and \$3.35 billion
- · EPS expected between \$0.41 and \$0.45

DALLAS (March 10, 2008) – In a scheduled update to its business outlook for the first quarter of 2008, Texas Instruments Incorporated (TI) (NYSE: TXN) today lowered its expected ranges for revenue and earnings per share (EPS).

The company's expectations for revenue are:

- · Total revenue between \$3.21 billion and \$3.35 billion, compared with the prior range of \$3.27 billion to \$3.55 billion;
- · Semiconductor revenue between \$3.14 billion and \$3.26 billion, compared with the prior range of \$3.20 billion to \$3.46 billion; and
- · Education Technology revenue between \$70 million and \$90 million, unchanged from the prior range.

TI expects EPS between \$0.41 and \$0.45, compared with the previous range of \$0.43 to \$0.49.

The company will hold a conference call at 4 p.m. Central time today to discuss this update. This conference call will be available live at www.ti.com. TI's original first-quarter outlook was published in the company's fourth-quarter and year-end 2007 earnings release on Jan. 22, available at www.ti.com. TI's first quarter ends on March 31.
