DALLAS (June 8, 2011) – In a scheduled update to its business outlook for the second quarter of 2011, Texas Instruments Incorporated (TI) (NYSE: TXN) today narrowed and lowered its expected ranges for revenue and earnings per share (EPS).

The company currently expects its financial results to be within the following ranges:

- \cdot Revenue: \$3.36 3.50 billion, compared with the prior range of \$3.41 3.69 billion
- EPS: \$0.51 0.55, compared with the prior range of \$0.52 0.60
